Hello! We warmly welcome you to Pliable's mobile COVID-19 vaccination clinic.

**Pfizer-BioNTech, Moderna, and Janssen (Johnson & Johnson) COVID-19 vaccines will be offered (as supplies allow)**

**Please bring your CDC vaccination card with you to your appointment, if you have had any prior doses. Please read the below, including the CDC and WA DOH information regarding COVID-19 Vaccinations and have your questions answered *before registering*.**

**By proceeding and scheduling online, you are consenting to the following terms below as the patient or surrogate decision maker for the patient, including minors.**

- My registration/signature is my self- attestation that I am eligible to receive the vaccination
- I understand it is not possible to predict all possible side effects or complications associated with receiving the COVID-19 Pfizer, Moderna, or Johnson&Johnson vaccine.
- I am encouraged to sign up with v-safe: <https://vsafe.cdc.gov/>
- I acknowledge that I have been advised to remain near the vaccination location for observation for 15 minutes after administration, 30 mins if I have a prior history of allergic reactions to vaccines.
- I give my consent to Pliable LLC, including licensed employees, volunteers, and partners, to administer the Pfizer-BioNTech COVID-19 vaccine , Moderna COVID-19 vaccine , OR Johnson&Johnson COVID-19 vaccine and have read info provided in text and links below. Neither these entities or Pliable host facilities/business can be held liable for adverse outcomes.
- PREP Act Authorization for CDC COVID-19 Vaccination Program Governor Jay Inslee's Proclamation by the Governor 20-05, issued on February 29, 2020 and subsequently amended, is a Declaration of Emergency. Covered Persons include, among others, any person authorized in accordance with the public health and medical emergency response of the Authority Having Jurisdiction to prescribe, administer, deliver, distribute or dispense the Covered Countermeasures, program planners, and their officials, agents, employees, contractors and volunteers, following a Declaration of Emergency. <https://www.govinfo.gov/content/pkg/FR-2020-03-17/pdf/2020-05484.pdf>
- I authorize and understand Pliable LLC may be required to or may voluntarily disclose my vaccine- related health information to my insurance plan, state or federal registries, and/or other public health authorities, for purposes of payment or health care operations.
- I understand that I am not creating a patient relationship with Pliable LLC by participating in vaccination. I understand Pliable LLC is not acting as my medical provider. Vaccination does not replace treatment by my medical provider. I agree I will seek medical advice, care and treatment from a medical provider if I have questions or concerns, or if I experience side effects.
- I have been provided expectations for the day of my vaccination.

- I acknowledge that I have read the vaccine Fact Sheet and agree to these terms and conditions. This registration and attestation serves as consent. No additional written consent is required

**On the day of your appointment:**

- Eat something.
- Vaccination is available for free, regardless of your citizenship or immigration status.
- Wear a short-sleeved shirt or clothing that allows access to your upper arm.
- Masks are required at all times at the clinic. If you do not have a mask one will be provided to you.
- Please arrive no earlier than 10 minutes prior to your scheduled appointment time. Appointment cannot be guaranteed if you arrive late.
- Do not visit the site if you are experiencing symptoms of COVID-19 on the day of your appointment.
- If you have a history of serious allergic reactions (anaphylaxis) and are prescribed an epinephrine auto injector (EpiPen, etc.) please bring this to your vaccination appointment and notify clinical staff.
